TJ's Driving School and students agree to the following terms and conditions set forth: Students are expected to conduct themselves in a professional, responsible, and appropriate manner at all times regardless if in the classroom or in the vehicle. Required clothing during and behind the wheel instruction will be appropriate school attire.

Qualifications: TJ's Driving School policy requires students to have a Beginner's Permit in order to be accepted into the program. Students must also be at least 15 years. TJ's Driving School can take the student to the DMV for the purposes of attaining their Driver's License. In order for TJ's Driving School to take the student to the DMV for the road test, the student must have held their Beginners Permit for 180 days.

- Fees: \$350.00 – 8 hours classroom and 6 hours BTW plus \$50 for Road Test. Total cost \$400.00
 - \$15.00- Beginner's permit exam
 - \$50.00 BTW – 2 hour min. (specific area),
 - \$50.00 – car rental, DMV (each attempt),
 - \$20.00 – duplication of any form previously issued,
 - \$30.00 – bank returned checks.
 - All tuition and fees will be collected prior to receiving any documents, course of instructions or services.

Refunds: No refunds after completing a portion of training, i.e Classroom or Behind the Wheel.

TJ's has a right to increase prices if gas goes beyond \$4.00 a gallon.

Behind the Wheel Vehicle: The vehicle to be used during the Behind the Wheel portion of the instruction is modified according to the SCDMV with dual brakes, inside mirrors, and signs denoting the name of the school and " Driver Training".

TJ's Driving School reserves the rights to cancel any lessons, but will reschedule within a reasonable time frame. Delays can be caused by acts of nature that could result in unsafe driving conditions, mechanical failures or any other reason over which the school has no control. TJ's Driving School request that a 24-hour notice is given if a student cannot meet scheduled appointment.

The student understands that certain hazards are risks are inherent in the operation of motor vehicles. The student does hereby specifically assume all such risks as may be incurred in the normal operation of a motor vehicle during the course of instructions. Each vehicle is fully insured with liability coverage.

TJ's Driving School does not guarantee or assure any student success in passing any examination given by the SC Department of Motor Vehicles. Each student must carry any documentation giving him/her driving privileges during training.

Course Certificate: Students who successfully complete the 14-hours of instructions from TJ's Driving School will receive a certificate of completion. 15&16 year olds will also receive a signed South Carolina Department of Motor Vehicle PDLA form. The signed PDLA form will make the student eligible to take the Road Test. 17 year olds and older are not required a PDLA form.

I will dedicate myself to practice driving and be respectful to fellow students and TJ's Driving School Staff.
